IMPORTANT

- Follow these instructions carefully! If your bowel is not clean when you arrive for the procedure, your procedure may be canceled.
- On the day of the procedure, you will not be able to drive. Plan to have a family member or friend drop you off and pick you up. If you do not have a ride planned, your procedure may be canceled.
- The day before the procedure, you must be on a clear liquid diet all day (from the time you wake up until midnight) - drink as much as possible! **NO SOLID FOOD.**

Medications

7 DAYS PRIOR TO COLONOSCOPY

- **Stop** iron tablets, multivitamins, nutritional supplements, Advil, Motrin, Naproxen, Meloxicam, or Diclofenac.
- If you take Aspirin, Plavix (clopidogrel), Coumadin (warfarin), Pradaxa (dabigatran etexilate mesylate), Brilinta (ticagrelor) or Effient (prasugrel), **STOP IT 5-7 DAYS BEFORE THE COLONOSCOPY.**

2 DAYS PRIOR TO COLONOSCOPY

- **Stop** Eliquis (apixaban) or Xarelto (rivaroxaban).

DIABETES MEDICATION

Take only half of your usual dose of diabetes tablets/insulin the DAY BEFORE your colonoscopy. **DO NOT TAKE ANY DIABETIC MEDICATION/INSULIN ON THE DAY OF COLONOSCOPY.** You may resume your usual dose of diabetes medications following your first meal after the colonoscopy.

BLOOD PRESSURE MEDICATION

If you take medication for your blood pressure, continue your medication. Take this medication on the day of the procedure with a small sip of water only.

Colon Prep

1 DAY PRIOR TO COLONOSCOPY

1. At **5PM** Prepare the laxative. Mix one packet of pouch A and pouch B in the disposable container. Fill it with water up to the marked "Fill Line." Mix to dissolve.
2. The MoviPrep container is divided by 4 marks. Start drinking the laxative. Drink **8 ounces every 15 minutes**. Finish the laxative within **1 hour**
3. Drink two 16oz bottles of water over the next **1 hour**.
4. Continue a clear liquid diet until **midnight**.

MORNING OF THE COLONOSCOPY

1. **5 hours** before colonoscopy mix the last pouch A and pouch B in the disposable container. Fill it with water up to the marked "Fill Line." Mix to dissolve.
2. The MoviPrep container is divided by 4 marks. Start drinking the laxative. Drink **8 ounces every 15 minutes**. Finish the laxative within **1 hour**.
3. Drink two 16oz bottles of water over the next **1 hour**.
4. **NOTHING TO DRINK**, including water, **2 hours** before check in time.

Clear Liquid Diet

- Water
- Black coffee (NO cream or milk)
- Green tea
- Clear sodas (Sprite, 7-Up, Mountain Dew, Ginger Ale)
- Clear juices (apple juice, white grape juice, lemonade)
- Light-colored sports drinks
- Crystal Light
- Chicken broths
- Gelatin flavors (Jell-O) with no fruit added, **no reds, purples or other dark colors**
- Popsicles

AVOID citrus juices, milk products
